## Task – 75 Marks

Prepare a case essay that outlines the key legal issues in your chosen case. You should include:

- The key facts from the case,
- The legal arguments that have been presented, and
- An analysis of the judicial decision.

Your case essay should be of **1,000 words**.

## Guidance

Follow the guidelines below when writing your assignment.

### Introduction

- Look carefully at the topic above and decide what information to include.
- Check your list of ideas to make sure you have responded to the task fully.
- Organise your ideas and make a plan for your case essay. You should refer to this plan when writing and you must submit this plan with your work.
- Your introduction should be clear and outline the purpose and planning for the assessment.

### Presentation of Legal Facts

- Your case essay must show a clear understanding of the key legal facts required for the assessment.

### Structure

- Your case essay should have a clear structure that is logical and easy to follow.
- The reader should be able to identify an introduction and conclusion, and the purpose of each paragraph.
- Paragraphs should have a topic and concluding sentences and link well to each other.
- You need to consider the audience for your case essay (the marker) and write your work in a suitable style, using appropriate vocabulary and correct grammar.

### Presentation

- Your case essay must be presented in a clear manner.

### Understanding and Analysis of Legal Arguments

- Your case essay must contain evidence of a good understanding and analysis of legal arguments.

### Proofreading

- You need to proofread your case essay to check for spelling, punctuation, grammar, and vocabulary errors.
- Check your word count and ensure you have the right number of words for each case essay. You need to include the word count (in brackets) at the end of each case essay.

## Submission requirements

- Your case essay must be word-processed, justified, and double-spaced. Your outline may be word-processed or handwritten. If it is handwritten, make sure that your writing is legible!
- You will need to hand in a printed copy of your Case essay, with the *Statement and Confirmation of Own Work* form attached.
- You will need to submit an electronic copy.
- You will need to include your name and NCC Education student number in the header on every page of your case essay.
